Developments

Reviews of the clerkship and pre-clerkship courses have been very positive. We continue to develop more effective teaching and assessment practices. This year we plan to introduce a longitudinal module beginning in first year so as to expose students to the complexity and dynamic nature of the discipline.

The psychiatry interest group continues. This is student-lead, but well supported by staff and residents.

An exciting development is the introduction of new faculty to take over the undergraduate curriculum. Dr. Behnia Haghiri will be the clerkship director and Dr. Kevin Varley will be the pre-clerkship director. Dr. Fitzpatrick will mentor through their first iteration.

A number of our faculty have taken on significant roles in the undergraduate medical program. Dr. Cherie Jones is the Director of Clinical Skills for Queen's Medical School and Dr. Renee Fitzpatrick is the Director of Student Affairs.

Research

Dr. Renee Fitzpatrick and Dr. Cherie Jones received a grant from the teaching and learning committee, which was supplemented by the Department of Psychiatry Research Fund to develop a module for depression which will be delivered over the course of first and second year. Dr. Fitzpatrick is chairing a sub-committee of COUPE to develop a national psychiatry curriculum.





Developments

The Psychiatry Residency Program welcomed five PGY-1's to the Residency Program: Marcelo Crespin, Jennifer Martins, Niki Mofidi, Liad Salz, and Ewa Talikowska-Szymczak. Sarah Penfold joined us as a PGY-2 resident.

The Residency Program Committee (RPC) revised the academic half-day schedule and psychotherapy teaching. Some of the highlights of the teaching schedule include a teaching series on child and adolescent psychiatry, anxiety disorders, developmental disabilities and workshops in cultural competency.

Education

Residents are involved in the development of the curriculum which includes academic seminars, small group teaching sessions and workshops that promote interactive resident and faculty participation. Residents are encouraged to pursue their interest in teaching junior colleagues or students or research and the program supports their involvement in all of the academic missions of the Department of Psychiatry.

The program has provided protected time every Wednesday from 1:00 – 4:30 for residents to attend their academic teaching which includes interviewing skills, PDM's as well as core seminars. Residents attend courses in Cognitive Behaviour Therapy (Dr. Michela David) and supportive psychotherapy (Dr. Leslie Flynn).

Awards/Honours

Dr. Nazanin Alavi received the American Psychiatric Association/Lilly Resident Research Award as well as the Dan Offord Resident Research Award, which is given by the Association of Professors of Child and Adolescent Psychiatry of Canada to commemorate the work that Dr. Dan Offord had done in the area of Child and Adolescent Psychiatry in Canada. The goal of the award is to encourage and recognize research by resident trainees in Child and Adolescent Psychiatry.

Dr. Varinder Parmar received the 2013 Coordinator of Post Graduation Psychiatric Education (COPE) Examination Resident Award and was nominated for the 2013 PAIRO Resident Teaching Award.

Developments

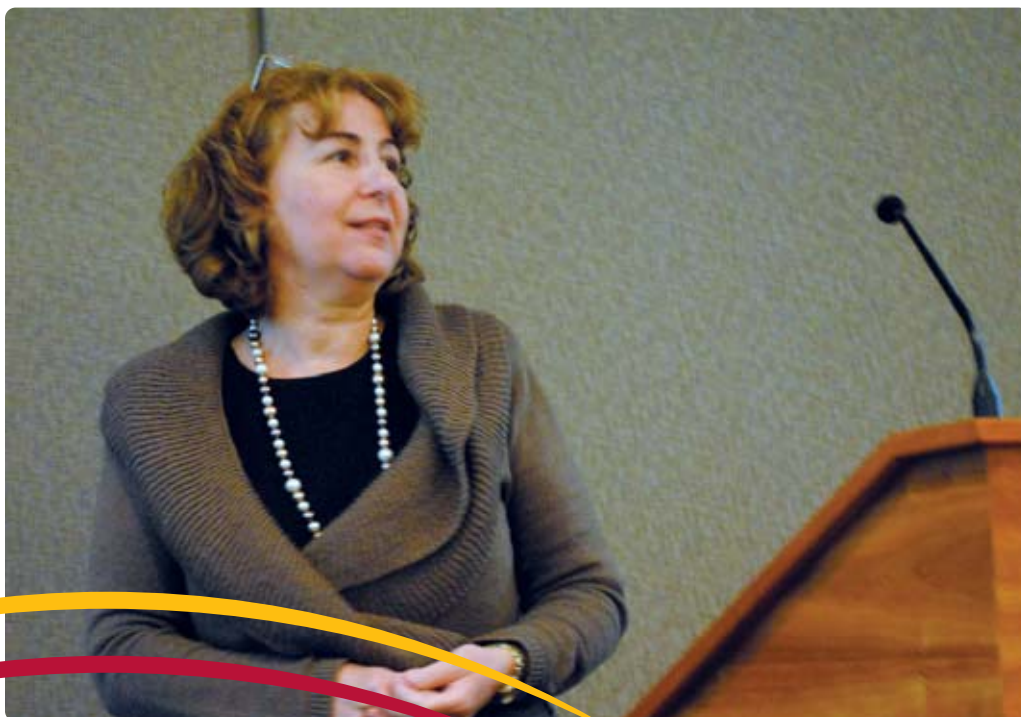
We distributed certificates of attendance for faculty in 2013, which confirmed the CME credits for hours attended.

The CME committee had a meeting January 31, 2014 and confirmed that we have the following types of rounds:

- 1 Rounds featuring guests from other universities whose work is internationally recognized. In the future, we plan to focus on colleagues from Toronto, Montreal and Ottawa
- 2 Rounds presented by each division. In these, the divisions report on their achievements, activities and collaborations
- 3 Collaborative Care Rounds which will facilitate learning from one another and fostering new ideas of how to improve quality of care and collaborative research
- 4 Research Rounds, which are every 3 months, in which faculty and residents can showcase their ongoing research
- 5 Morbidity and Mortality Rounds every 3 months
- 6 Resident Rounds: These rounds help trainees develop collegiality in an academic environment

The CME committee plans to do needs assessments and report their results at the spring retreat.

The CME committee is working on revising the evaluation forms. There is also work being done on having teleconferencing between sites in Kingston perform smoothly. Through teleconferencing between sites, we aim to foster knowledge and translation to other specialties.

DIVISION OF adult mental health

(AMH) formerly known as Adult Treatment and Rehabilitation Services

Developments

In 2013, the AMH program underwent a redesign, going from four inpatient units to three and achieving the Health Services Restructuring Commission bed target of 60 inpatient beds. Two units will focus on recovery, wellness and resilience engaging the clients in intensive treatment, symptom management, improving functioning and living skills and engaging with supports to enable their return to the community, while the third unit will focus on enabling recovery by providing positive behavioural techniques, skills acquisition and adapting the environment to enable success. Individuals often present with a primary psychiatric diagnosis and concurrent developmental delay, addiction, acquired brain injury or other diagnoses that increase the complexity of the care required. Clients are assigned to the unit which provides the best clinical "fit" for that client's unique challenges.

The reorganization of our inpatient services from four to three units has significant implications for both our clients and staff as we redefine and refocus our service delivery. A new collaborative outpatient team, Adult Mental Health Outreach Services, was initiated and has been working with partners such as Health Links. The Community

Outreach Team transferred many of the clients who were seen by a psychiatrist only to be followed by Collaborative Mental Health Services.

Thanks to a grant from Scotiabank, we have moved forward with the expansion of outreach in the Lennox & Addington and Hastings counties. Recruitment is now complete and staff are providing services in these communities.

AMH's Schizophrenia Rehabilitation Service continues to participate in a quality initiative on Medication Administration Improvement, sponsored by Janssen Pharmaceuticals. Members from the ACT teams and the CHIT team are involved in all stages of medication management from procuring the prescription to administering the medication.

AMH staff have been engaged in meetings and planning sessions around the new hospital. We

continue to look at every aspect of the hospital and how we can best provide care and services to our clients in a new physical surrounding.

Suicide Prevention Training was developed and provided to all clinical staff by Murray Hillier and Sue Lewis. A team of trainers provided a series of sessions to all hospital clinical staff throughout May and June.

Karin Carmichael and Dr. Simon O'Brien were nominated and selected to participate on the SE LHIN Redesign Task Force which represents the diversity of clients and organizations in the SE LHIN and have been commissioned to develop various models of what the future of mental health services could look like. The SE LHIN will ultimately be responsible for determining which model most appropriately addresses the needs of providers, clients and the region as a whole.



VOCEC has partnered with the YMCA to create a new business which employs 18 business associates since June 2013. It produces upwards of 300 meals and 700 snacks per week for children attending the YMCA daycare. In addition to providing meals for the daycare, they have also partnered with the YMCA to create the Breaking Ground Café. Breaking Ground provides YMCA members and staff with a selection of items baked and prepared by VOCEC associates. Together with the YMCA, COVEV has provided a supportive work environment where Providence Care clients can grow and thrive – economically, professionally and personally.

AMH was successful in obtaining a \$33,500 grant from Bell Canada as part of their Let's Talk Community Fund that focuses on mental illness and fighting stigma. The grant enabled the Community Connections Recovery Program to further develop the Hope and Discovery Artisan's group through a series of arts based workshops. It also provided funds to engage professional artists to work with the other clients to develop skills in the areas of visual arts, music, photography and drama. Creative projects developed were based on the themes of access to health care, community inclusion and stigma reduction in our community. The resulting work was showcased from October 4 – 11, 2013 at a public arts festival in support of anti-stigma awareness.

This project has provided meaningful opportunities for people living with mental illness to develop their abilities and showcase their work to a mainstream audience, thus helping to reduce the stigma of mental illness in the general population and the self-stigmatization of those with mental health concerns.

AMH staff are actively engaged in ongoing ePR training in anticipation of the upcoming transition to an electronic record. Several members of the AMH staff are actively involved in this process as ePR Champions or ePR Trainers.

A joint initiative between Frontenac Community Mental Health and Addictions Services (FCMHAS) and Providence Care – Mental Health Services (PC-MHS), to transition legacy clients from an inpatient setting to the community will be taking place over the next eighteen months. The primary goals of the initiative are to:

- Transfer legacy clients from hospital to community housing and reduce inpatient beds
- Improve the quality of life of legacy clients consistent with recovery principles and values
- Implement new structures and processes to guide an integrated approach to service delivery that interconnect community and hospital services to best meet the needs of legacy clients in the community

This project will result in a system re-design that has the potential to transform services to provide an integrated, community-centred and recovery-oriented approach to meeting the needs of individuals with serious mental illness in the community. The project involves a formal collaboration between FCMHAS and Providence Care to discharge and support enhanced community living for legacy clients. The initiative will be grounded in appreciative inquiry and participatory leadership approach that will seek to engage staff of the two organizations and extended health service and community partners in a process of collaborative knowledge exchange, idea sharing and mutual learning. The aim of this process will be to draw upon the knowledge, skills and resources of all relevant partners (including legacy clients and their family members) to build a network to generate the best possible options for these individuals (e.g., community housing, flexible service delivery between hospital and community).

Recruitment

We welcomed Dr. Muhammad Ayub to AMH. Dr. Ayub was appointed as the Co- Chair of the Division of Developmental Disabilities in August 2013 and in November he joined our psychiatry team taking over the care of two inpatient beds for clients who are dually diagnosed.



Tanzania

In July, Dr. Feakins married Charlene, an Occupational Therapist working for the Community Integration Team with Providence Care. In lieu of wedding gifts, they asked for donations to fund a short psychiatric mission to Tanzania, which they completed in October and November.

Tanzania is located on the east coast of Africa. It has been politically stable since 1962, and has a relatively strong economy by comparison with other countries on the continent.

They were based in Moshi, a small city which is also a base for expeditions to Mount Kilimanjaro and the Serengeti. Dr. and Mrs. Feakins had a few days' orientation in a general hospital and specifically the psychiatry services. They were surprised to see how well resourced the hospital was with staff and medications, for patients who had money and access. It was noted that computers and phone landlines were not available for the frontline staff but cell phones were widely used. Charlene was specifically impressed with their wide use of peer volunteers working in collaboration with

professional staff (e.g. individual with spinal cord injury training a newly affected patient on how to do transfers).

Afterwards, they began seeing community patients at their homes and in clinics. Developmental delay and epilepsy were seen frequently, as well as the usual range of psychiatric disorders. Many patients who saw them were unable to meet the mandatory fee of \$3 for seeing doctors, and unable to pay for their prescriptions. Through the charity who organized the trip, CACHA, they were able to arrange coverage for older antipsychotics,

antidepressants and anticonvulsants, mostly haloperidol, chlorpromazine, carbamazepine and amitriptyline. Basic lifestyle education, such as on the importance of avoiding alcohol and drugs, was well received. In developmental delay, Charlene was able to intervene with structured recommendations to deal with disruptive behaviour and to improve general welfare.

They concluded that whilst many Tanzanians were obviously underprovided with healthcare resources, most had considerably better psychiatric support from relatives, friends and neighbours than in Canada or Britain. Psychiatric disabilities were integrated seamlessly into family and community life. Each patient was given a role and responsibilities that matched their ability, such as fetching the family's water, looking after children, or doing the neighbours' heavy lifting. The result was a highly effective occupational therapy program for most patients.



Unfortunately, not all patients were so well integrated. Stigma was much less subtle than in Canada or Britain, and several patients were victims of severe neglect, starvation, and sexual abuse. Witchcraft remains a prevalent belief, co-existing with Christianity or Islam, and was held responsible for many psychiatric diagnoses.

Dr. and Mrs. Feakins continue to reflect on their experiences, which changed both their practice and their ability to deal with the frustrations of Canadian psychiatry. They strongly recommend the experience to colleagues who wish to broaden their experience of psychiatry, and would be delighted to be contacted for further details.





Emergency Psychiatry

In late 2013, two new initiatives were started in Emergency Psychiatry. Case conferences are being organized for identified frequent users of hospital inpatient and emergency psychiatric services. A 24-hour call back program for patients seen in psychiatric emergency at KGH then discharged is being developed and implemented.

Inpatient Psychiatry

We have recruited a family physician to the ward, who is invaluable in dealing with medical co-morbidities of Burr 4 patients.

In 2013, the proposal for the transitional intensive treatment program at KGH has been further developed and submitted. The LHIN board has approved funding for the TITP to start in early 2014.

Consultation/Liaison Psychiatry

Two clinical fellows are currently completing fellowships in CL psychiatry. The CL team facilitates bi-weekly teaching rounds and weekly geriatric psychiatry teaching rounds.

In 2013, a number of changes to CL psychiatry have been implemented in part as a result of feedback from a survey done in 2012. The consultation/liaison psychiatry service has undergone several changes in the last year. A sincere and reinvigorated effort at increasing the social capital of our department with the medical and surgical services has begun and appears to be successful. We have resumed provision of regular consultations with St. Mary's of the Lake hospital, and feedback has been excellent. The KGH inpatient consultation service has seen an expansion of consultation sources and an enhanced level of team interactions. This has been

reflected in many positive correspondences from our consulting colleagues. Wait times for outpatient CL consultation has been reduced. We have received and will be accommodating requests for teaching sessions from Internal Medicine, Critical Care and Palliative Care as we move into 2014. We have resumed teaching a full compliment of residents and medical students in addition to our clinical fellows. We are proving consultation liaison case-based teaching rounds alternating every other week with Emergency case based teaching rounds. We have also established a regular handover routine with the on-call teams to ensure continuity of patient care.

Developments

Dr. Carolyn Woogh retired from the division this year. We would like to thank her for her long and exemplary service to the division. Dr. Dijana Oliver has shifted her work from CL psychiatry to full-time inpatient psychiatry. Thank you to Dijana for her contributions on the CL service.

A warm welcome to all the new psychiatrists who have joined our division this year – Dr. Muhammad Habib, Dr. Behnia Haghiri, Dr. Moustafa Eid, Dr. Kevin Varley, Dr. Khalid Saeed and Dr. Farooq Naeem have all joined the division.



Dr. Alina Marin has taken on the role of Director Continuing Medical Education and Faculty Development for the Department. Dr. Leslie Flynn has taken the position of Vice Dean, Health Sciences Education, Queen's University.

Divisional members organized, hosted and presented the annual conference on Early Intervention in Psychosis. They also organized, hosted and presented at the annual ADHD conference, special thanks to Dr. Alina Marin.

Dr. Alina Marin and Dr. Duncan Scott continue to provide accredited knowledge translation sessions for Family Physicians.

A proposal for a transitional intensive treatment program at KGH has been developed in close collaboration with the LHIN and community partners and was submitted. The LHIN board has approved funding for the program.

Dr. Susan Finch was a member of the SEO Mental Health Redesign Task Force, and divisional members have been actively involved in giving feedback to the process.

Dr. Pallavi Nadkarni is developing pathways for psychiatry referral in patients of Cystic Fibrosis with depression – liaising with Lisa Smith, Nurse (Fellowship project).

Education

Dr. Leslie Flynn has developed and implemented a supportive psychotherapy teaching and supervision clinic for PGY 2 residents which have been well received. Dr. Flynn is also very actively involved in medical education scholarship at the University, National and International level.

Dr. Susan Finch was nominated for the PAIRO Excellence in Clinical Education award for 2013 and also became a member of the Royal College Examination Board for psychiatry in 2013.

Education

In addition to Departmental appointments, Division members have responsibilities in their discipline specific departments or school including undergraduate and postgraduate teaching. This arrangement allows for knowledge dissemination and cross-fertilization of ideas in the field of dual diagnosis and autism spectrum disorders. Students from different disciplines gain clinical experience with developmental disabilities and also benefit from working and learning within a collaborative patient-centred healthcare team.

Interprofessional Teaching Activities

In addition to clinical training, the DDCP (Developmental Disabilities Consulting Program) faculty members are also involved in modeling and promoting an interprofessional education and practice model. In these activities there is an active and overt effort to have "clinicians from different professions" teach "students from different professions" so that interprofessional collaboration can inherent in the learning process. Even when teaching activities are specifically directed to a single discipline of students, the course material is jointly delivered by DDCP team members so as to model interprofessional teaching and practice.

Education

The major areas of education offered in the past year have been the SBAR communication tool, Metabolic Syndrome and Diabetes, Best Practice for IM injections, TB and Mantoux training, Least Restraint training, reviews of Suicide Assessment Tool, Mental Status examination and tool to prepare for GRIT education, Community Treatment Orders, and the Enhancing Our Relationships course. Training was done with new equipment: the Bladder Scanner, the suction machine and the BP tower.



Developments

Mobile Response Team – a 24/7 Service

In 2013, significant strides were accomplished including the establishment of a 24/7 access for Long-Term Care and the establishment of a fully functioning Mobile Team across South Eastern Ontario.

The establishment of the Mobile Team has involved continuous refinement through listening to our partners using quality tools and approaches such as KAIZEN events and value-stream mapping, as well as skill-building and learning from others to implement this new innovative service. The outcomes have been significant in terms of establishing and shifting the way that we provide supports and services. We have decreased

the length of response time for service from 40 hours to 14; the MRT alone has provided over 5,200 contacts in only a 9-month period.

Person-Directed Care: From Rhetoric to Reality

This year marked the establishment of an innovative approach to ensuring that the person and family had meaningful involvement in not only their own individual care but in informing our Program development and evaluation. This occurred through the establishment of a Lived Experience Coordinator and the initial development of a network whose mandate is defined across the three critical dimensions:

- Hearing voices of individuals and families about their lived experiences to refine,

understand and appreciate the strengths and gaps in our system;

- To provide guidance and input from the network and the lived experience to develop our services over time; and
- To define and support person-directed skill-building for our staff so that we have the skills to ensure that information, knowledge and approach of our clinicians enable the person and caregiver to be an active participant in his or her care.

Finally, the Virtual Lived Experience Network is making strides in terms of being actively involved in our evaluation of services as we incrementally and evolutionary change to a new way of doing things.



Building our Strengths and Improving our Service Activities through Quality-Driven Approaches

In 2013, major changes in planning, development and implementation have occurred within and between our services and our partners. This has involved the development of new models and approaches to increase specialty access to the primary care system through collaboration with the developing Health Links. In addition, the service has allocated resources and supports to enable better interfaces with the Hospital within the health care system and has developed a number of protocols and approaches aimed at delivering better transitional care and integrated care across our system. We have been fortunate enough to build on the many years of experience of existing outreach/shared care services and Psychogeriatric Resource Consultants to enable us to build and integrate them with

our new direct transitional and mobile services that have recently been supported by BSO and LHIN investments.

In addition, due to the success and also identification of increasing need for better transitions, the Program was the recipient this year of an additional \$1.8 million ongoing funding from the LHIN to support increasing transitional support services, adding another “service” pillar in the transforming health care system for the population.

We have also continued our Provincial leadership in 2013 as members of our Service and Division have taken on and continue to be involved in major Provincial as well as National initiatives in research, education and service delivery. This has involved the appointment of one of our administrative staff to take on a leadership role at the Provincial level for the continuation of implementation and evaluation of BSO across all LHIN areas.

The South Eastern Ontario Knowledge Exchange LHIN Based Network Development

Continuing our leadership in knowledge exchange; bringing it to the South East Region.

The Clinical and Academic Division and Service continues to establish itself as a leader in knowledge mobilization and exchange through its Provincial and National activities with the National Dementia Knowledge Exchange housed at Queen's Division of Geriatric Psychiatry and Behavioural Health, as well as continuous leadership in Provincial networks, i.e., AKE and SHKN,

Learning and experience in leading edge approaches have this year been applied to the development of a LHIN-based SEO Knowledge Exchange to enable better co-creation of new approaches and designs in health delivery, enable best evidence to be brought to bear in practice, and support for the implementation of web-based platforms to enable better sharing and innovation across the region. Web platforms have been established as well as skill building of our staff in Knowledge Translation so this can be a continuing strategy to inform and promote improvements in our LHIN developments for our target populations.



Service Changes and Volumes

This year has continued to involve increasing pressures on the Geriatric Psychiatry and Behavioural Health Services within increasing volumes in each of the districts of South Eastern Ontario region. The Service has redefined itself in terms of three functional components – direct services where upon the specialty teams are involved in direct service delivery to the clients combined with a continuation of our shared care outreach services and a new primary emphasis on integrated care where individuals, i.e., specialty care managers and psychiatrists are embedded and working within family health teams or specific hospital organizations. This tripartite service delivery functional approach is proving itself invaluable to support and enhance our capacity to provide a continuum of services that enable better prevention, early detection, and linkages across the health care system, as well as support the continuum of services for those with moderate and high needs, individuals and their caregivers.

Our district community teams, shared care and Mobile Response components from April 2012 – March 2013 have provided support for over 1300 new consults and referrals.

Awards, Honours and Leadership

In 2013, the Division and Seniors' Mental Health Program has been fortunate to have attracted two new Fellows, one who will be continuing her Fellowship in August of this year and a new Fellow who will be joining us in July. In addition, we are in the process of submitting an application for Royal College recognition, at which time we will be able to provide a full array of research, education and service experiences for training in this new sub-specialty.

Related to the designation of the Fellowship by the Royal College, this year, Dr. Melissa Andrew was

awarded the Outstanding Contributions to Geriatric Psychiatry in Canada by the Canadian Academy of Geriatric Psychiatry for her work in developing and bringing the reality of our sub-specialty status. Dr. Dallas Seitz also continues to receive the Southeastern Ontario Academic Medical Organization, Queen's University, Clinician Scientist Development Program Award.

We have also strengthened our approach in skill building, infrastructure support for the development of systems clinicians and psychiatrists aligned with the vision and directions of the Dean and Faculty of Health Sciences at Queen's for Psychiatry.



IN memoriam

Jim Owen died this past year after a lengthy illness. In spite of his illness he had continued to contribute to the Department of Psychiatry until shortly before his death. Jim was a psychopharmacologist who had been with us for 30 years. His commitment to work even when he was not well was typical of, not only his dedication, but his love of teaching and research. He was an outstanding teacher and well loved by many generations of students and residents. One of the things that made him such an outstanding teacher was his gentle approach to students, his empathy with learners and his natural curiosity about psychiatry and education. He wrote extensively and was probably known better at other centers than at Queen's because of his quiet and humble approach to his research and writing. Just before his death the second edition of the "Clinical Manual of Psychopharmacology in the Medically Ill" (which Jim Co-authored) was released. This is an invaluable clinical resource for many clinicians which I still refer to on a weekly basis. He also co-edited "The American Psychiatric Publishing Textbook of Psychosomatic Medicine" which should soon be publishing a new edition. He created and produced a number of educational CD's and on-line learning programs.

Anyone who spent any time with Jim would remember how easy and comfortable it felt to talk with him. He had a wonderful ability to put us at ease and enter into conversations that could go in any direction. He had a mind that was interested in many, many areas and we never left a conversation with Jim without knowing more than when we started.

Jim was a natural collaborator. He loved to work with other people and he stimulated creativity in those of us who were fortunate enough to work with him. I used to search him out to teach with me because I always learned so much when we worked together. He always left us feeling valued and wise and wanting to learn more.

Jim was a wonderful resource to the community. Many family physicians have spoken about how valuable he was to them when they had questions or needed a pharmacological consultation.

More importantly than all of this is the man who Jim was and the life he lived. He was one of the kindest, most ethical, loving and thoughtful men I have known in my lifetime. His life was rich with friends because he knew how to be a good friend. His relationship with his wife and partner, Sue was remarkable to watch because of the depth of their attachment and love for each other.

Jim will be missed, not only at Queen's, but by many people in many places.

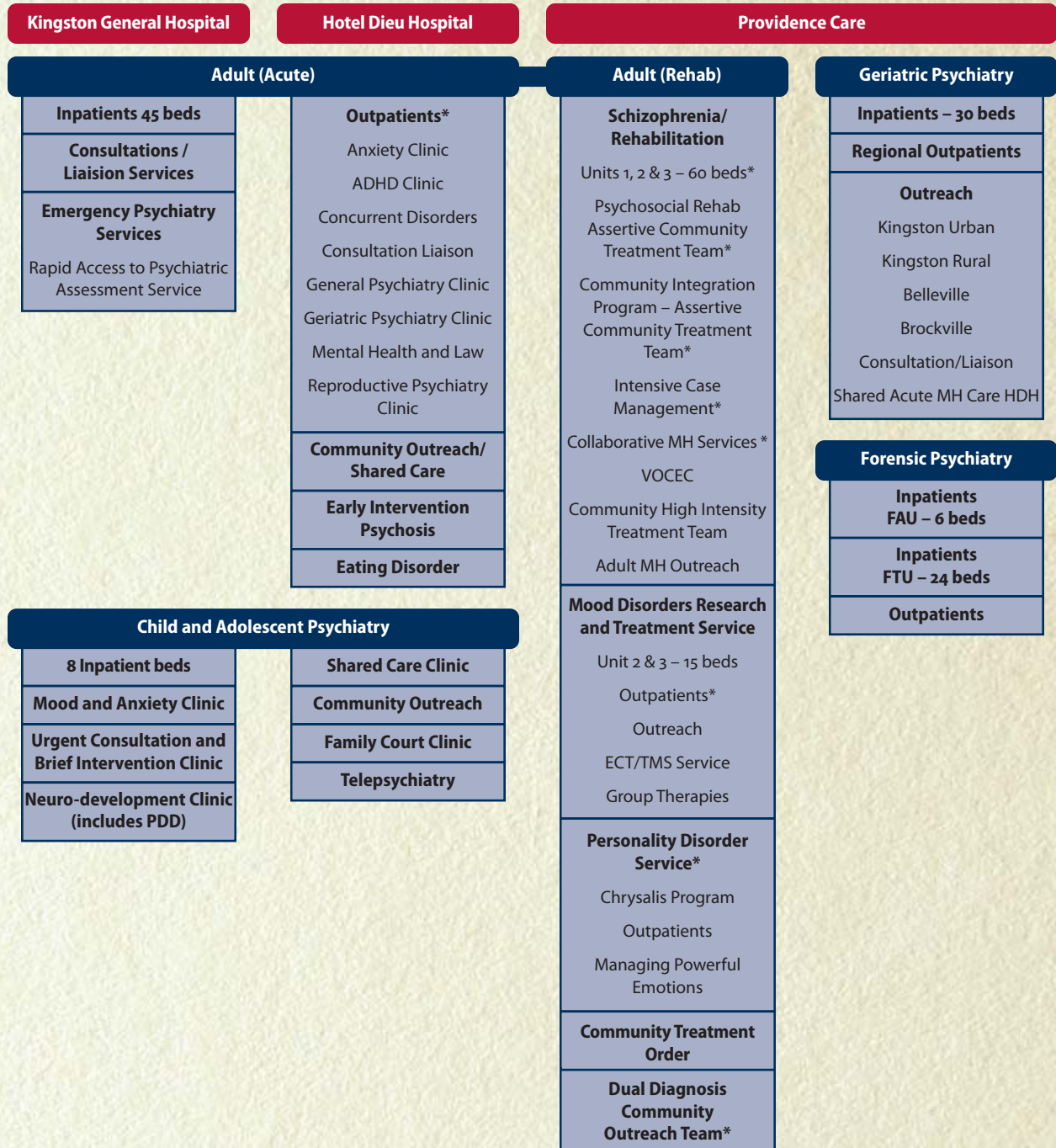

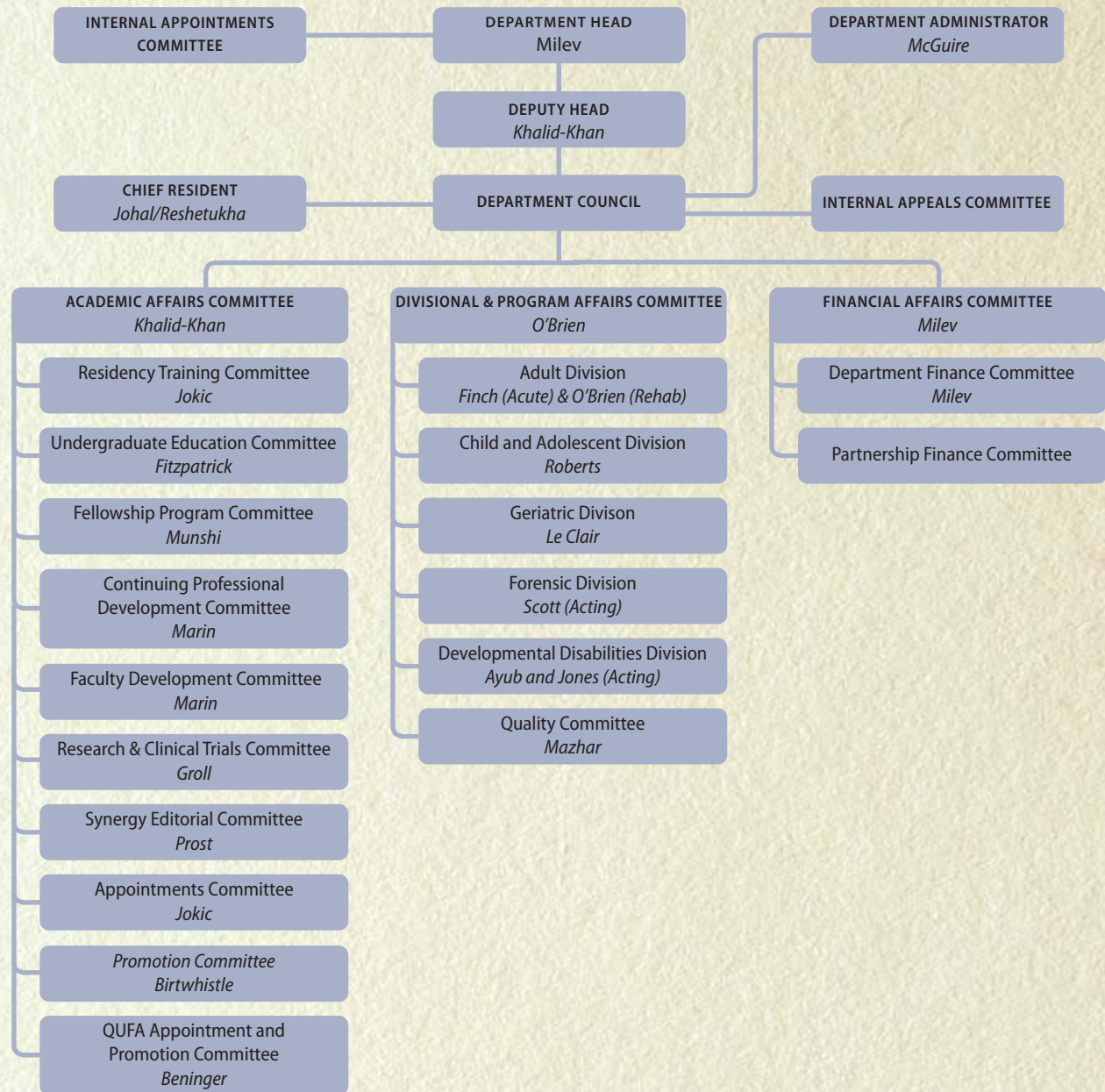

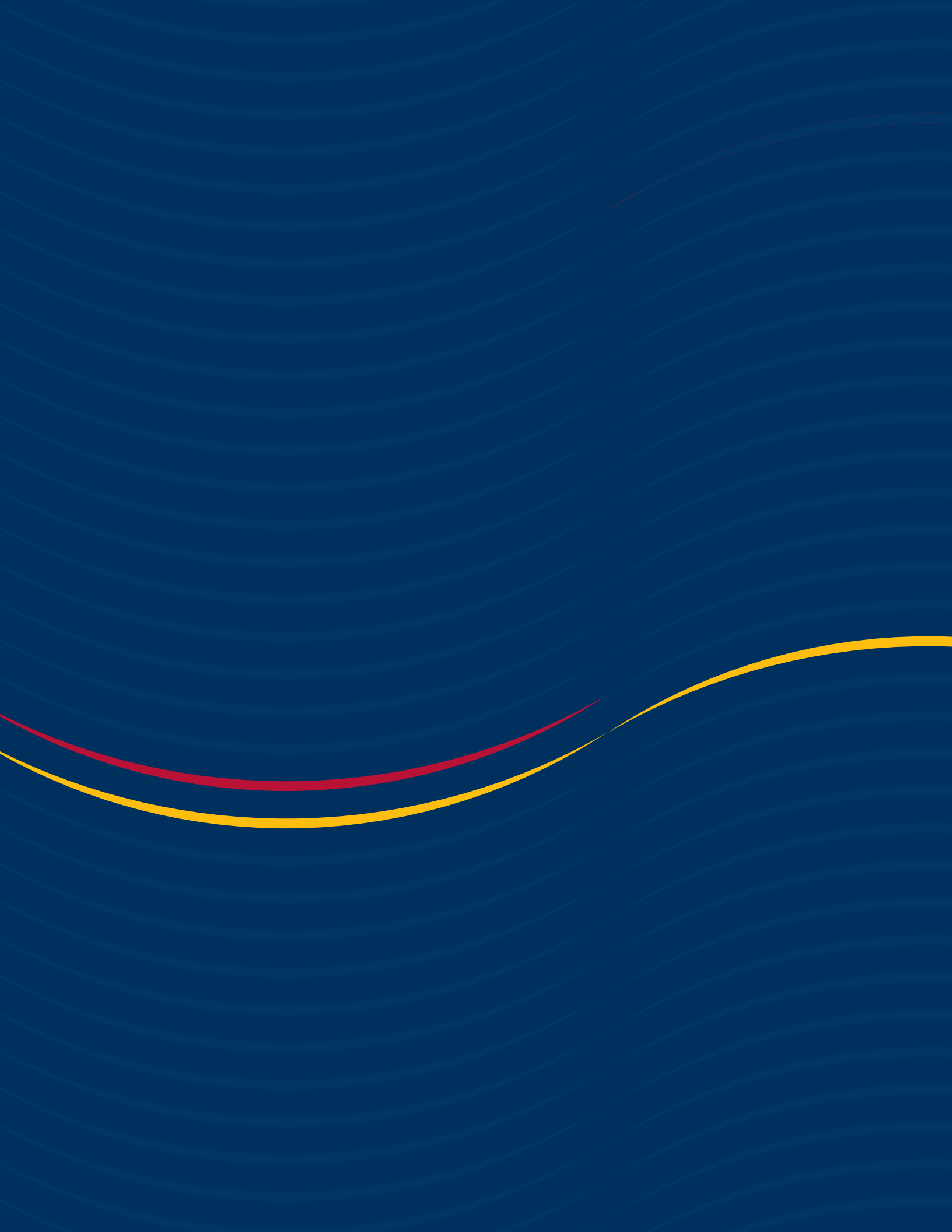
